REQUEST FOR PROPOSAL

The Department of Tourism – Office of Product and Market Development (OPMD), thru its Bids and Awards Committee (BAC), intends to procure Public Relations (PR) Management Retainer for Dive Philippines through Small Value Procurement (SVP) under Section 53.9 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184. The details of the procurement project is indicated in the table below:

TERMS OF REFERENCE

PROJECT TITLE

Public Relations (PR) Management Retainer for Dive Philippines

DESCRIPTION

The Office of Product and Market Development (OPMD) – Dive is in need of the services of a competent agency to create and execute a public relations campaign for the Dive Philippines brand.

OBJECTIVES

- 1. To highlight the rich marine biodiversity in the Philippines' destinations
- 2. To heighten awareness on the Philippines' initiatives to promote sustainable dive tourism
- 3. To sustain interest in the Philippines as the World's Leading Dive Destination

MINIMUM REQUIREMENTS

- A. Must be a Philippine organization capable of providing Public Relations (PR) Management services;
- B. Must be accredited with the Philippine Government Electronic Procurement Systems (PhilGEPS); and
- C. Must be willing to provide services on a send-bill arrangement.

SCOPE OF WORK AND DELIVERABLES

- A. Design a comprehensive and relevant Public Relations (PR) campaign based on target consumers profile that is in line with the Department's objectives to sustain interest in the Philippines as the World's leading dive destination and heighten awareness on initiatives undertaken to promote sustainable dive tourism;
- B. REQUIRED PERSONNEL

C. PR MANAGEMENT

- Develop communications concepts and messages based on sound marketing/communications principles and market knowledge/insights;
- Develop a PR strategy that will drive awareness, engagement, and conversion;
- Generate international and local media list in collaboration with the end-user;
 - i. International media list must be comprised of the following: combination of travel, sports, lifestyle and dive publications and online communities;
 - ii. Local media list must be comprised of the following: major broadsheets, relevant travel bloggers, and print/online magazines (travel, sports, lifestyle);
- Develop and maintain relationships with key media relevant to the dive market that will translate to an increase in positive exposure for Dive Philippines;
- Develop relevant story angles and generate at least 3 press releases on the team's projects and initiatives, with provision for at least 2 revisions per release;
- Distribute/seed press releases to relevant platforms and channels (across major newspapers, magazines, and online sites) with at least 5 guaranteed pick-ups (2 international and 3 local) for each release;
- Provision for liaising a maximum of (2) one-on-one press interviews between identified industry personalities / Department executives and relevant media outlets, as needed/requested by a particular media outlit;
 - i. Coordination only with interested media outfit for one-on-one interview
 - ii. Preparation of digital briefing guides for media Q&A and executive briefing;
 - iii. Medium of interview will be online via Zoom / Google Meet due to current circumstance;

D. MONITORING AND REPORTING

- Monitor releases, publications, and airings, as applicable;
- Compile all international and local exposures made on Dive Philippines on a monthly basis for submission to the team;
- Prepare analysis of monthly performance reports for all components;
- Generate report on final media reach, values, and mileage earned for the duration of the engagement.

BUDGET

The total working budget is **NINE HUNDRED NINETY-NINE THOUSAND PESOS (P 999,000.00)**, inclusive of 12% VAT, and should cover all requirements enumerated above. Contract duration shall run from awarding of contract until December 31, 2020.

In the event that the DOT is able to secure sponsorships, the corresponding value must be deducted from the total amount in the invoice.

The winning bidder shall be determined based on the proposal with the most advantageous financial package cost, provided that the amount does not exceed the above total budget.

PAYMENT TERMS

- First Tranche: 20% upon presentation of comprehensive plan, subject to approval;
- Second Tranche: 30% upon submission of mid-project report on media reach, values, and mileage;
- Third Tranche: 50% upon submission of final media reach, values, and mileage for the duration of the engagement.
