TERMS OF REFERENCE

(RT-PCR Testing)

I. Project: Procurement and Services of COVID-19 Testing for the conduct of Executive Course on the National Accommodation Standards in the New Normal for the Regional Directors.

II. Project Description: The project will entail the conduct of Reverse Transcriptase Polymerase Chain Reaction (RT-PCR) test for the personnel of Tourism

Regulation, Coordination and Resource Generation (HCIDP, OIMD, OTSR),

Officials/Regional Directors/Officers-In-Charge and the invited resource speakers who will be physically present during the conduct of the Executive Course on the National Accommodation Standards in the New Normal for the Regional Directors. As the country still continues to be under the State of Public Health Emergency, a negative RT-PCR test result for COVID-19 is a requirement by some LGUs prior entry to their locality.

III. Effectivity: August 1-31, 2021

IV. Minimum Requirements for Bidders

1. Bidders must be a DOH Accredited and/or partnered with multiple Department

of Health (DOH) accredited testing facilities to process their test specimens. Bidders must be able to show proper documentation of accreditation.

2. Has duly trained medical personnel to safely perform COVID-19 swab test (RTPCR)

and specimen collection.

3. Must be willing to provide services on send-bill arrangement.
