1. Department of Trade and Industry (DTI) business name registration or SEC Certificate, whichever may be appropriate under existing laws of the Philippines supported with the necessary information using prescribe forms.
2. Valid and current Mayor's permit/municipal license.
3. Statement of ongoing Government and private contracts including contracts awarded but not yet started
4. Statement of all Completed Government and private contracts which are similar in nature
5. Audited financial statements, stamped "received" by the BIR or its duly accredited and authorized institutions, for the immediately preceding calendar year, showing among others the total current liabilities
6. Computation of Net Financial Contracting (NFCC), OR *Certificate of commitment specific to the contract at hand, issued by a licensed bank to extend to the bidder a credit line if awarded the contract*, which shall also be specific to the contract to be bid, in an amount not lower than that set by the procuring entity in the Bidding Documents, which shall be at least equal to ten percent (10%) of the approved budget for the contract.

8. Latest Income/Business Tax Return (For ABC above PhP500, 000.00)
9. Original or Certified True Copy of Duly Notarized Omnibus Sworn Statement
