### Description

REQUEST FOR PROPOSAL BIDDER Service Provider (Video Production Company)

PROJECT TITLE Audio-Visual Presentation (AVP) (Motion Graphics) of the Philippine Commission on Sports SCUBA Diving (PCSSD) "Health and Safety Guidelines Governing the Operations Dive Establishments Under Community Quarantine and in the New Normal"

### BACKGROUND OF THE PROJECT

The Philippine Commission on Sports SCUBA Diving (PCSSD) is an attached agency of the Department of Tourism (DOT) that serves as the regulating body for recreational SCUBA diving in the country. As such, the Commission is mandated to promulgate programs, projects, and activities geared towards the development of the country as a premier diving area in Asia, by formulating and implementing rules, regulations, safety standards, and operating procedures.

In line with the Commission's mandate, the PCSSD has issued the "Health and Safety Guidelines Governing the Operations of Dive Establishments Under Community Quarantine and in the New Normal." Thus, the PCSSD is in need of the services of a video production company that can produce a 6-minute AVP (Motion Graphics) on the health and safety guidelines.

#### MINIMUM REQUIREMENTS

A. Must be willing to provide services on send – bill arrangement;

- B. Must be Philippine Government Electronic Procurement Systems (PhilGEPS) registered;
- C. Must have at least 3 years of experience in AVP (Motion Graphics) production;

D. Must be able to provide a dedicated team to the Commission as specified in the Qualifications of this Terms of Reference; and

E. Must adhere to the DOT and PCSSD's branding guidelines in accordance with industry best practice.

OBJECTIVE

To properly and effectively communicate PCSSD's Health and Safety Guidelines Governing the Operations of Dive Establishments to its stakeholders through an AVP (Motion Graphics).

SCOPE AND WORK DELIVERABLES

A. Production of a 6-minute informative AVP (Motion Graphics) that will feature PCSSD's Health and Safety Guidelines Governing the Operations of Dive Establishments Under Community Quarantine and in the New Normal.

C. Production, Editing, and Final Output

Must allow a minimum of two (2) virtual sessions in the editing suite with a PCSSD

representative/s;

• Final output must include a an 6-minute AVP (Motion Graphics); and

• Final output must be submitted to PCSSD on a 1 TB external hard drive, which includes the raw file/s, assets, and final rendered file of the video (Resolution: 1920x1080).

D. Project Timeline

• Pre-production (Total of 11 days):

- Upon clearance for notice to proceed by the BAC Secretariat: 1-day briefing with PCSSD to discuss branding guidelines and expectation setting;

- One (1) week after 1-day briefing: Submission of storyboard to PCSSD; and

- Three (3) days after PCSSD reverts back with storyboard revisions: Submission of revised storyboard to PCSSD.

• Production (Total of 28 days):

- Upon approval of the storyboard: The winning bidder may begin production for a maximum of three (3) weeks. A PCSSD representative/s must be updated via two (2) virtual sessions in-between this period;

- After three (3) weeks of production: Virtual meeting with PCSSD for submission of 1st draft; and

- One (1) week after virtual meeting with PCSSD: Revise 1st draft according to PCSSD's inputs on virtual meeting, and submit to PCSSD as 2nd draft.

• Post production [Total of seven (7) days]:

- Submit final rendered file to PCSSD one (1) week after revision from 2nd draft.

QUALIFICATION OF COMPANY/REQUIRED PERSONNEL

Bidder has accomplished at least 3 general video production works/projects; bidder that has accomplished at least 1 to 2 video production work/s or project/s relative to dive will be an advantage.
Bidder that has handled at least 1 video production work/project for other government agencies would be an advantage.

• A Production Head or Project Director has handled a regular video production work/project and must provide references of their past projects; an experience handling project/s relative to dive is not required, but would be an advantage.

• Scriptwriter, Illustrator, Animator/Motion Graphics Editor, and Video Editor has handled a regular video production work/project and must provide references for their past projects; an experience handling projects relative to dive is not required, but would be an advantage.

Note: Bidder may go beyond the abovementioned personnel provided that the cost for the personnel is within the project cost.

BUDGET - Total budget for this project is FOUR HUNDRED AND FIFTY-FIVE THOUSAND PESOS (PhP 455, 000.00) VAT inclusive. - The winning bid shall be determined by the Department of Tourism based on the most acceptable proposal and most advantageous financial package cost, provided that the bid amount does not exceed the above total budget. - The budget is inclusive of all revision fees, and other pertinent fees relative to the scope of work and deliverables mentioned above.
