Terms of Reference for the services of a Travel and Tour Operator

For the Monitoring and Evaluation of WTTC Safe Travels Stamp Recipients and the PDOT-WTTC Safe Travels Forum November - December 2021

I. BACKGROUND

In September 2020, the Philippines became the 100th destination to receive the World Travel and Tourism Council Safe Travels Stamp (WTTC STS) recognizing the alignment of the country's Health and Safety Guidelines for tourismrelated sectors to that of the council's and the emergence of local tourism destinations which are opening up for domestic tourists with no quarantine requirement.

Following this, the Department of Tourism has been given the opportunity to assume the role of a Safe Travels Ambassador to the stakeholders, advocating the implementation of the Safe Travels protocols and the uptake of the Safe Travels stamp to subsidiary public sector authorities and/or private sector organization and ensure their ongoing compliance with the protocols and Terms & Conditions.

As of 31 October 2021, the Department has issued the stamp to three (3) local tourism destinations, which are Baquio City, Boracay Island, and Ilocos Norte having been compliant with the WTTC Core Requirements, and to two hundred seventeen (217) DOT-accredited accommodation establishments nationwide. To ensure the Philippine recipient's full compliance with the WTTC Safe Travels Protocols and the DOT Health and Safety Guidelines as well as to evaluate and assess the impact of the WTTC STS to their establishments' performance and operations, the DOT through the Office of Tourism Development Planning, Research and Information Management (OTDPRIM) with the

Office of Tourism Standards and Regulations (OTSR) and the DOT Regional Offices shall conduct a monitoring and evaluation of select recipients in the following destinations: Inclusive Dates Region / Destination 24-27 November 2021 Region VI | Boracay Island 01-03 December 2021 Region VII | Cebu 06-08 December 2021 CAR | Baquio City 13-14 December 2021 **NCR** Moreover, to maximize the benefits of the Philippines as a WTTC STS recipient, the PDOT-WTTC Safe Travels Forum with the theme: Tourism Industry: Emerging from the Crisis and Gearing for a Sustainable Future for Tourism will be hosted through a hybrid format on 26 November 2021 in Boracay. The forum aims to discuss the importance of crisis preparedness in the tourism industry, the experiences of WTTC STS destinations in advocating for Safe Travels and the lesson learnt from the pandemic in gearing for a sustainable future of tourism. It is expected to be attended by expert resource persons, with up to 25 on-site participants* and over 500 online participants. In this regard, the DOT-OTDPRIM is in need of a DOT-Accredited Travel and Tour Operator to provide requirements on meals, accommodation, and local transportation, and RT-PCR.
